2) your personal data, indicated in point 10), are processed exclusively for the following purposes:

- compliance with the rules in terms of Health and Safety at the workplace
- legitimate interest for the protection of corporate goods

The legal bases of treatment are:

- the existence of legal obligations to which the holder is subject, pursuant to Regulation (EU) 216/679 Article 6 paragraph 1 letter c)
- the existence of a legitimate interest by the owner, pursuant to Regulation (EU) 216/679 Article 6 paragraph 1 letter f), consisting of the protection of corporate assets

3) your personal data will not be communicated to third parties

4) your personal data will not be transferred to third countries or international organizations.

5) your personal data will be stored for twelve months and then will be deleted by destroying the support on which they are recorded

6) you have at any time the right to ask the data controller the access of your personal data, the correction or the cancellation of these data if they are treated in a manner not compliant with current regulations or the limitation of its treatment. To exercise this right, it is necessary to present a written request to the owner through one of the indicated contact channels

7) in case of violation of your rights or incorrect treatment by us of your personal data, you have the right to contact the Privacy Authority, which acts as a supervisory authority for the Italian territory

8) the communication of personal data is a necessary requirement for access to business premises, then the missing communicate of these data involves the access impossibility.

9) your personal data will not be processed by an automated decision-making process
