## INFORMATION REGARDING SUPPLIERS

NR COVIS SRL, as data controller of the personal data conferred from you, pursuant to Art.13 of Regulation (EU) 216/679, informs you that:

1) the data controller is reachable via the following channels:

2) your personal data, indicated in point 10), are processed exclusively for the following purposes:

- conclude sale contracts
- fulfill the pre-contractual, contractual and tax obligations arising from relations with you
- exercise the rights of the owner, for example the right to defense in court

The legal bases of treatment are:

- fulfillment of obligations deriving from the signed sales contract (Reg. UE 2016/679 Article 6 paragraph 1 letter b)
- the existence of a legitimate interest by the owner, pursuant to Reg. EU 2016/679 Article 6 paragraph 1 letter f), consisting of the correct administrative and financial management of the relationship with his customers

3) your personal data may be disclosed to
